

Park rules and parking rules for visitors of « Les Etangs du Bos »

Welcome to « Les Etangs du Bos »

You are starting a stay at « Les Etangs du Bos » that, we hope, gives you lots of enjoyment. However, we ask you to abide by the usual rules for consideration and precaution.

Above all, this means to show responsibility for you and for others, always be polite.

Furthermore, to avoid problems, we ask you to respect the following rules for the park and the parking.

1. Parking

Our car park is subject to the provisions of the Highway Code, road signs included.

To avoid traffic circulation problems we ask you to conscientiously follow the signs and the instructions that may be given by the personnel.

Park your vehicle so it doesn't hinder the traffic flow and respect the places reserved for the handicapped.

The car park and your vehicle are not under surveillance.

When you leave your vehicle, ensure that you have locked the doors, boot, windows and sunroof and that you have not left anything of value in the car.

We also ask you not to leave any animal in the vehicle.

If your vehicle is stolen or damaged, we cannot be held responsible, this is also valid if damage is caused by a storm, fire, hail, an explosion or other unforeseeable events.

2. Entrance ticket

Visitors can only enter the park if they have a valid entrance ticket.

The entrance ticket should be kept throughout the stay in the park and produced to our staff if requested. The tickets are only valid the day of purchase.

Entrance authorisation becomes invalid if the visitor leaves the park without prior authorisation.

Persons under the influence of drink or drugs may be refused entry to the park and may be escorted off the site.

3. General safety rules

- 1) Dogs are welcome in the park but must be kept on a lead at all times. In certain areas of the park, marked with signs, dogs are not allowed and should not be allowed too near the swimming and paddling pools.
- 2) Smoking is prohibited when using any of the attractions and make sure cigarettes are completely extinguished to prevent an outbreak of fire.
- 3) Weapons and offensive items (pistols, knives, chains, knuckle-dusters etc) must not be carried within the park.
- 4) Visitors must follow the instructions issued by the park personnel.
- 5) Noise, the use of radios and cassette players is forbidden.
- 6) Visitors going to swim or to related water games must have a swimsuit (swimming shorts are allowed if they are only used for this purpose) jeans, cut offs or other casual shorts are not allowed for reasons hygiene.

4. Use of the facilities and attractions in the amusement park

The facilities in the park are at your disposal as long as **the respective rules and the tariffs for their use are observed**. Please follow the instructions given by the operating staff.

If you deliberately ignore the instructions for use and the instructions given by the operating staff, the operating staff may prevent you using the attraction without this giving rise to any claim for compensation on your part. This also applies if you attempt to push to the front of a queue, instead of waiting your turn.

You will be held liable for all damage caused by ignoring the instructions for use and for malicious damage.

In the case of an interruption of the power supply due to thunderstorms, strong winds or other occurrences and a resultant failure of certain facilities and attractions, a refund or partial refund of the entrance fee cannot be demanded.

5. Use of games

Certain games are only for children, adults must not use these games, respect the indications.

6. Swimming

We ask you to read the bathing safety recommendations on the notice board; to reduce the dangers associated with this activity. Only, the swimmers can go on the inflatables games on the lake.

7. Duty of supervision

We would like to stress to all parents and group leaders that they have a duty to supervise their charges very attentively. Group leaders and parents are therefore also responsible for any damage caused by the persons in their charge.

8. Restriction of liability

Visitors may only hold us liable for damage caused by the malice or gross negligence of our staff and in particular, we cannot accept any liability for items brought into the park.

9. Damage reports

All the facilities in the park are maintained and supervised carefully. Nevertheless, if you suffer any damage or injury through no fault of your own, please report this to reception before leaving the park. Please also report to us if you suspect that damage may occur later as a result of some event. Claims for compensation shall not be permitted if a possible and reasonable damage report is not made until after you leave the park

10. Publicity and the sale of products and services

Publicity within the area of the park and the car park, as well as the sale of products and services is only permitted with a prior written consent of the management. This also applies for conducting opinion polls. Whatever means are used, publicity and announcements for organisations, associations, interest groups and individual ideas are prohibited within the park and inside all buildings, rides etc; these initiatives will be punished in each individual case with expulsion from the park and civil prosecution for disturbance of domestic peace and security.

11. Filming and photography for publicity purposes

Photography and filming is carried out in the park. If you do not want the photographs or recordings of yourself to be used at a later date in public, please inform the photographer or film team of your wishes.

If you do not take this step, we assume that we may use all such photographs or recordings free of charge.

12. Park rights

The amusement park is entitled to eject persons who violate the park rules or who are found on the park site without a valid entrance ticket. We will not be liable for any damage to personal property.

In the event that one or several of the attractions may not be operating, there will be absolutely no refund in any form whatsoever.
